Marie Arnold has a show called California Abstract Landscape in March on a couple of the walls on the Mezzanine at Gallery 113.

Originally from Quebec, Canada, she has spent most of her life living in California. She is captivated by the different landscapes from the mountains to the sea and also impressed by the sheer vastness of the State. Wanting to capture the immensity of this place, she chose to work on larger formats than she usually does. Most of these paintings are 30x40 inches, with some larger at 36x36 inches.

From the Pacific Ocean to the forests of the Sierra, California landscapes are a constant source of inspiration. During various times of the year, the landscape changes from dry summers where forests often burn without respite to the calming and serene forests of the dark winters where colors merge with the sky.

She has purposefully not given names to all of the paintings, as she would rather you connect with the colors, feelings, and sensations.
