Vice President's Message



Hi everyone, Nancy Hull here standing in for Cathie Smith,

Happy New Year everyone! Despite numerous Covid-related restrictions – and cancellation of the annual art show at the Santa Barbara International Orchid Show (also for 2022) - the past year brought SBAA an unexpected opportunity – being able to have shows at the Faulkner Gallery for six con-I would like to thank secutive months. Kathrin Rosenburger at the downtown library for easing our way through this unprecedented marathon, and I'd also like to also express my gratitude to all you members who participated – as volunteers and exhibitors – in these shows. Our art has provided much-needed enjoyment to hundreds of viewers during these shadowed times.

Looking into 2022, the February 19 show change at 1919 State St. will be our first show of the new year. For those of you unfamiliar with this venue, here's a little information. This is a 3-story medical building that has a lot of foot traffic – including folks waiting around for appointments which are running late - during the workweek, and sales are generally good. This venue accepts only 2-dimensional art but can accommodate some fairly large pieces. Sales are handled by the artist, so there are no gallery This is a juried show – commissions. 'though often all submissions are accepted – so sold pieces may not be replaced. show runs for three months, and I encourage you to enter, especially if you've not done so in the past.

May will bring a very exiting opportunity for us, a 9-month show at the Channing Peake Gallery (at the Santa Barbara County Administration Building, 105 E Anapamu). It's been a number of years since SBAA has had a show there, and the planning for this event is taking place while the newsletter is being put together. So, I don't have a lot of details yet, just the confirmation from the Santa Barbara County Office of Arts and Culture. It will be a juried show, and if your art is accepted, it must remain in the show for the show's entirety. Stay tuned...

Later in the year, we will have juried shows at the Faulkner in June, July, November and December, in addition to the quarterly shows at 1919 State – May, August and November. We anticipate jurying in new members again in early April and once again in the fall. Plans for our annual celebration at the Glen Annie Golf Club are on hold due to the state of the epidemic. Lastly, every month you have the opportunity to enter the monthly (and non-juried) show at Gallery 113, or to rent wall space as a featured artist. This arrangement with the gallery is provided by SBAA, but - repeat after me - **SBAA** and Gallery 113 are separate organizations. (If you have questions or concerns about Gallery 113, please take them up with the one of its board members.)

You can see from this summary of what's scheduled, so far, for 2022, there are numerous opportunities both for exhibiting your art and for volunteering to assist at these events. I hope the new year brings you renewed artistic inspiration and energy! And as for volunteering, please don't hesitate to reach out to me to add your name to the list for a specific event or for a specific activity.

CITY OF SANTA BARBARA BUSINESS LICENSE

This is required for all artists showing their art for sale in the City of Santa Barbara whether they live in the City of Santa Barbara or not! For example, if you show your work at Gallery 113, at the Faulkner gallery, or at 1919 State St. show. There is no charge for the license if your income from art sales is less than \$5,000 a year and you identify your art as Arts/Crafts Home, however, you must have the license.

Go to City Hall to fill out the Business Application form at 735 Anacapa St. where water bills are paid Monday – Thursday from 10 – 2 PM (current covid schedule) or register online at www.Santa BarbaraCA.gov

Once registered, you will receive annual renewal forms from the City.

CALIFORNIA SELLER'S LICENSE

The California Department of Tax and Fee Administration requires that if you are selling your art directly to a buyer and not through a gallery, you must register and collect CA tax on a sale in California and report it online annually. For example, a sale from 1919 State St. show. This is not required if your art is being sold through Gallery 113 as they have their own seller's license and collect the tax and report it to CA State for you. This is part of the service they provide that is included in their commission. For example, in a Gallery 113 show or SBAA Faulkner show sale handled through Gallery 113. Go to www.CDTFA.CA.gov to apply for the license.

In addition, if you are selling under a name other than your own, you will need to register that name under Fictitious Name but we haven't researched the details on that.


